AMENDMENT TO DECLARATION OF CONDOMINIUM FOR THE ALDREDGE CONDOMINIUM

(Annexation of Building 1 - Units 1, 2, 3 and 4)

This AMENDMENT TO DECLARATION OF CONDOMINIUM FOR THE ALDREDGE CONDOMINIUM (hereinafter called the "Amendment") is made this 14th day of October, 2016, by **PULTE HOME CORPORATION**, a Michigan corporation (hereinafter called "Pulte" or "Declarant"), for the purposes of submitting additional property to the Declaration of Condominium for The Aldredge Condominium and the Georgia Condominium Act, O.C.G.A. § 44-3-70, et seq. WHEREAS, JW Homes, LLC, a Delaware limited liability company ("JW Homes"), submitted certain property to the Act and to the Declaration of Condominium for The Aldredge Condominium by that certain Declaration of Condominium for The Aldredge Condominium, recorded November 12, 2015, at Deed Book 25258, Page 39, et seq., in the DeKalb County, Georgia land records (hereinafter as such document may have been supplemented and/or amended from time to time referred to as the "Declaration"); and

WHEREAS, condominium floor plans for The Aldredge Condominium are filed in Condominium Floor Plan Book 239, Page 30, et seq., aforesaid records; and in Condominium Floor Plan Book 242, Page 21, et seq., aforesaid records; and

WHEREAS, a condominium plat for The Aldredge Condominium, prepared by Gunnin Land Surveying, LLC, is recorded in Condominium Plat Book 239, Page 23, et seq., aforesaid records; and in Condominium Plat Book 242, Page 18, et seq., aforesaid records;

WHEREAS, Section 19 of the Declaration provides that the Declarant reserves the right and option to expand the Condominium during the Expansion Period by adding to the Condominium and submitting to the Declaration and to the Act all or any portion of the Additional Property described on Exhibit "B" to the Declaration; and

WHEREAS, the Expansion Period, as defined in Section 2 of the Declaration, has not expired; and

WHEREAS, the Declarant is the Owner in fee simple of the Additional Property described on Exhibit "A", attached hereto and by this reference incorporated herein, and such property is a portion of the Additional Property that may be subjected to the Declaration and the Act by the Declarant; and

WHEREAS, the Declarant desires to amend the Declaration to submit the Additional Property described on Exhibit "A" hereto to the Act and to the Declaration; and

WHEREAS, floor plans for the Units located on the Additional Property for The Aldredge Condominium are filed contemporaneously herewith in Condominium Floor Plan Book 245, Pages 12-70, aforesaid records and a condominium plat for The Holland Records in Condominium Plat Book 245, Pages
Book 245, Pages 77 TO , aforesaid records; Pages Aldredge Condominium is recorded in Condominium Plat Book 245 , Pages 9 11 , aforesaid records;

NOW THEREFORE, the undersigned hereby adopt this Amendment to the Declaration of Condominium for The Aldredge Condominium hereby declaring that all of the property now or hereafter subject to the Declaration shall be held, conveyed, encumbered, used, occupied and improved subject of the Declaration, amended as follows:

Pulte Home Corporation, as Declarant, pursuant to the Declaration and the Act, hereby submits the property described on <a href="Exhibit" A" attached hereto and by this reference incorporated herein, together with all of the improvements located thereon, to the provisions of the Act and to the provisions of the Declaration. From and after the date on which this Amendment is recorded with the Clerk of the Superior Court of DeKalb County, Georgia, the property described on Exhibit "A" hereof, and all of the improvements located thereon, shall be owned, held, transferred, sold, conveyed, used, occupied, mortgaged or otherwise encumbered, subject to all of the terms, provisions and restrictions of the Declaration, as amended hereby, and of the Act. Except as amended herein, the Declaration shall remain in full force and effect.

Unless otherwise defined herein, the words used in this Amendment shall have the same meanings as set forth in the Declaration.

Except as herein modified, the Declaration shall remain in full force and effect.
