# WEST VININGS PLACE NEIGHBORHOOD ASSOCIATION, INC.

#### ARTICLES OF INCORPORATION

#### ARTICLE I

The name of the Corporation is: WEST VININGS PLACE NEIGHBORHOOD ASSOCIATION, INC.

#### ARTICLE II

The corporation (hereinafter sometimes referred to as the "Association") is organized pursuant to the provisions of the Georgia Nonprofit Corporation Code.

#### ARTICLE III

The initial registered office of the Corporation shall be at: 303 Peachtree Street, N. E., Suite 4300, Atlanta, Fulton County, Georgia 30308. The initial registered agent of the Corporation at such address shall be George M. Bobo.

#### ARTICLE IV

The name and address of the incorporator is George M. Bobo, 303 Peachtree Street, N. E., Suite 4300, Atlanta, Georgia 30308.

#### **ARTICLE V**

The purpose for which the Association is organized is to provide for the acquisition, construction, management, maintenance and care of the property now or hereafter contained within the WEST VININGS PLACE, a residential home development, pursuant to, and in accordance with the Declaration of Covenants, Conditions and Restrictions for

West Vinings Place to be recorded in the records of the Clerk of the Superior Court of Cobb County, Georgia (the "Declaration"). In order to carry out such purposes, the Association shall have all of the powers set forth in the Declaration, in the Georgia Nonprofit Corporation Code and provided by Georgia Law as being exercisable by a corporation formed for the purposes of exercising the powers of an association created pursuant to Georgia Law.

The Association is not organized for, and shall not be operated for, pecuniary gain or profit. No part of the net earnings of the Association shall inure (other than by acquiring, constructing, or providing management, maintenance and care of the property contained within the WEST VININGS PLACE NEIGHBORHOOD ASSOCIATION, INC. and other than by a rebate of common profits or excess assessments) to the benefit of any private individual.

# **ARTICLE VI**

The Corporation shall have members. Each person owning a unit (as defined in the Declaration) in the WEST VININGS PLACE NEIGHBORHOOD ASSOCIATION, INC. shall automatically be a member of the Association, which membership shall continue during the period of such ownership by such unit owner.

#### ARTICLE VII

The affairs of the Corporation shall be managed by a Board of Directors. The number of directors of the Corporation and method of appointment and election shall be set forth in the bylaws of the Corporation.

### ARTICLE IX

A. Each person who is or was a director or officer of the Corporation, and each person who is or was a director or officer of the Corporation who at the request of the Corporation is serving or has served as an officer, director, partner, joint venturer or trustee of another corporation, partnership, joint venture, trust or other enterprise shall be indemnified by the Corporation against those expenses (including attorneys' fees), judgments, fines and amounts paid in settlement which are allowed to be paid, advanced or reimbursed by the Corporation under the laws of the State of Georgia and which are actually and reasonably incurred in connection with any action, suit, or proceeding, pending or threatened, whether civil, criminal, arbitrative, administrative or investigative, whether formal or informal, in which such person may be involved by reason of his being or having been a director or officer of this Corporation or of such other enterprises. Such indemnification, reimbursement or advance shall be made only in accordance with the laws

of the State of Georgia, including the Georgia Nonprofit Corporation Code, subject to the conditions prescribed under such statutory provisions.

B. In any instance where the laws of the State of Georgia permit indemnification, reimbursement or advances to be provided to persons who are or have been an officer or director of the Corporation or who are or have been an officer, director, partner, joint venturer or trustee of any such other enterprise only on a determination that certain specified standards of conduct have been met, that all statutory requirements and procedures have been satisfied, and that upon application for indemnification, reimbursement or advances by any such person the Corporation shall promptly cause such determination to be made in accordance with the statutory procedures of Georgia law.

- C. Nothing in this Article shall be construed as limiting the applicability and scope of Georgia law with respect to indemnification, reimbursement and advances for expenses; further, as a condition to any such right of indemnification, the Corporation may require that it be permitted to participate in the defense of any such action or proceeding through legal counsel designated by the Corporation and at the expense of the Corporation.
- D. In accordance with the law of the state of Georgia, the Corporation may purchase and maintain insurance on behalf of any such persons whether or not the Corporation would have the power to indemnify such officers and directors against any liability under the laws of the State of Georgia. Any expenses or other amounts that are paid by way of insurance, or by indemnification, reimbursement, or advances of funds other than by court order, action by shareholders, the Corporation shall provide notice of such payment to the shareholders in accordance with the applicable provisions of the laws of the State of Georgia.
