ON THEIR DEEDED PROPERTY, SUBMIT A REQUEST FOR HOME AND LOT IMPROVEMENT APPROVAL TO THE ARCHITECTURAL REVIEW COMMITTEE FOR APPROVAL PRIOR TO INITIATING WORK ON PLANNED IMPROVEMENTS. IF ANY CHANGE IS MADE THAT HAS NOT BEEN APPROVED, THE HOA HAS THE RIGHT TO ASK THE HOMEOWNER TO REMOVE THE IMPROVEMENT FROM HIS PROPERTY. I UNDERSTAND THAT THE ARCHITECTURAL REVIEW COMMITTEE WILL ACT ON THIS REQUEST AS QUICKLY AS POSSIBLE AND CONTACT ME IN WRITING REGARDING THEIR DECISIONS. I AGREE NOT TO BEGIN PROPERTY IMPROVEMENTS UNTIL THE ARCHITECTURAL REVIEW COMMITTEE NOTIFIES ME OF THEIR APPROVAL.
